

2009 Agriculture & Fishery Establishment Survey

1. Agriculture Establishments

- The number of agriculture establishments increased by 8.2 percent to 6,824 in 2009.
 - The number of agricultural incorporated associations and agricultural companies rose by 522 and 12, respectively. The number of general companies fell by 13 due to worsening profitability.
- The number of workers increased by 6.5 percent to 37,681 persons in 2009.
 - The number of workers in agricultural incorporated associations rose by 1,359 persons. The number of workers in agricultural companies grew by 930 persons.
- The sales of agricultural products rose by 25.7 percent to 7,279.6 billion won in 2009.
- The agricultural land grew by 39.2 percent to 19,211ha in 2009.
- The government subsidies increased by 23.6 percent to 852.9 billion won in 2009.

2. Fishery Establishments

- The number of fishery establishments decreased by 3.8 percent to 605 in 2009.
- The number of workers increased by 2.6 percent to 2,866 persons in 2009.
- The sales of fishery products rose by 36.1 percent to 399.4 billion won in 2009.
- The aquaculture area went down by 1.9 percent to 1,342ha in 2009.
- The government subsidies increased by 35.9 percent to 34.6 billion won in 2009.
