

Preliminary Results of the 2022 Mining and Manufacturing Survey

- ◇ As for the 'Mining and Manufacturing' industry (with 10 workers or more) in 2022, the number of establishments, the number of workers, the value of shipments and the value added rose by 1.0%, 1.4%, 15.6% and 12.9%, respectively.
- □ The number of establishments in 'Mining and Manufacturing' (with 10 workers or more) was 73,595 in 2022, rising by 731 establishments (1.0%) from 2021. The number of workers in 'Mining and Manufacturing' was 2.991 million persons in 2022, rising by 43 thousand persons (1.4%) from 2021.
- (Number of establishments)

As for the number of establishments in 2022, 'Manufacture of other Transport Equipment', 'Manufacture of Food Products' and 'Manufacture of Fabricated Metal Products' rose by 176 establishments (11.9%), 170 establishments (2.7%) and 103 establishments (1.1%), respectively, from 2021. Whereas, 'Manufacture of Textiles, except Apparel' and 'Manufacture of Furniture' fell by 177 establishments (-6.1%) and 33 establishments (-2.5%), respectively, from 2021.



As for the number of workers in 2022, 'Manufacture of Food Products', 'Manufacture of other Transport Equipment' and 'Manufacture of Motor Vehicles, Trailers and Semitrailers' rose by 7.8 thousand persons (3.4%), 7.5 thousand persons (6.2%) and 6.8 thousand persons (2.1%), respectively, from 2021. Whereas, 'Manufacture of Rubber and Plastics Products' and 'Manufacture of Textiles, except Apparel' fell by 4.6 thousand persons (-2.1%) and 2.7 thousand persons (-3.6%), respectively, from 2021.



□ The value of shipments of 'Mining and Manufacturing' stood at 2,044.2 trillion won in 2022, rising by 275.2 trillion won (15.6%) from 2021. The value added of 'Mining and Manufacturing' stood at 726.5 trillion won in 2022, rising by 88.2 trillion won (12.9%) from 2021.




As for the value of shipments in 2022, 'Manufacture of Coke, Briquettes and Refined Petroleum Products', 'Manufacture of Motor Vehicles, Trailers and Semitrailers', 'Manufacture of Electrical Equipment' and 'Manufacture of Chemicals and Chemical Products; except Pharmaceuticals and Medicinal Chemicals' rose by 75.7 trillion won (61.2%), 34.4 trillion won (16.1%), 33.0 trillion won (29.2%) and 31.0 trillion won (16.6%), respectively, from 2021. 'Manufacture of Textiles, except Apparel' and 'Manufacture of Furniture' slightly rose by 0.9 trillion won (4.6%) and 0.1 trillion won (0.8%), respectively, from 2021.


As for the value added in 2022, 'Manufacture of Coke, Briquettes and Refined Petroleum Products', 'Manufacture of Electrical Equipment' and 'Manufacture of Motor Vehicles, Trailers and Semitrailers' increased by 34.6 trillion won (169.4%), 12.2 trillion won (34.3%) and 10.0 trillion won (16.2%), respectively, from 2021. 'Manufacture of Furniture' and 'Manufacture of other Transport Equipment' decreased by 0.2 trillion won (-4.2%) and 0.2 trillion won (-1.6%), respectively, from 2021.
