


Results of the 2020 Population and Housing Census (One-person households, housing status and vacant houses)

[One-person households: Population]

In 2020, unmarried one-person households recorded 3.341 million households, which occupied 50.3% of the total one-person households.


- O As for marital status of one-person households, in 2020, unmarried one-person households recorded 3.341 million households, which occupied 50.3% of the total one-person households. This figure was followed by widowed one-person households (20.5%), divorced ones (16.1%) and married ones (13.2%).
- Compared to 2015, the share of unmarried one-person households showed the highest increase of 6.4%p. Whereas, the share of widowed one-person households fell by 8.9%p.

Among one-person households with activity constraints (621 thousand households), households needing care amounted to 250 thousand households (40.2%).


- O One-person households with activity constraints amounted to 621 thousand households, which occupied 9.4% of the total one-person households.
- One-person households needing care due to activity constraints amounted to 250 thousand households (40.2%).
- 46.8% (117 thousand households) of one-person households received assistance from visiting caregivers. 23.6% (59 thousand households) of one-person households needed care, but had no one to take care of.

Among one- person households whose member was 20 years old or more, 53.3% (3.501 million households) provided their living expenses by themselves.

- O As for the source of living expenses of one-person households, among one-person households whose member was 20 years old or more, 53.3% (3.501 million households) provided their living expenses by themselves, which was followed by government subsidy (7.8%, 515 thousand households) and financial assets (7.1%, 465 thousand households).
- O Among one-person households whose member was 60 years old or more, 33.6% provided their living expenses by multiple sources, which was followed by government subsidy (21.1%) and respondent themselves (20.6%).


[One-person households: Household]

As for reasons for living alone of one-person households, the largest share of one-person households (2.278 million households, 34.3%) lived alone owing to their workplace.

O As for reasons for living alone of one-person households, the largest share of one-person households (34.3%) lived alone owing to their workplace, which was followed by 'to live independently' (26.2%) and family reasons (17.0%).

- As for reasons for living alone, 48.8% of unmarried one-person households lived alone due to their workplace. 48.0% of married one-person households lived alone due to their workplace.


[One-person households by reason for living alone (2020)]



As for the period of living alone of one-person households, the largest share of one-person households (1.364 million households, 20.5%) lived alone for '1 year ~ less than 3 years'.

- O As for the period of living alone of one-person households, the largest share of one-person households (1.364 million households, 20.5%) lived alone for '1 year ~ less than 3 years'. One-person households living alone for '20 years or more' recorded 973 thousand households (14.6%).
- One-person households living alone for 'less than 10 years' showed a higher figure among males. One-person households living alone for '10 years or more' showed a higher figure among females.


[One-person households by period of living alone (2020)]



As for living quarters of one-person households, detached houses marked the highest figure of 2.919 million households (43.9%). As for occupancy type of one-person households, 'monthly rent' recorded the highest figure of 2.735 million households (41.2%).

- O As for living quarters of one-person households, detached houses marked the highest figure of 2.919 million households (43.9%), which was followed by apartments (2.126 million households, 32.%) and living quarters other than housing unit (721 thousand households, 10.8%).
- O As for occupancy type of living quarters of one-person households, monthly rent recorded the highest figure of 2.735 million households (41.2%), which was followed by 'owner-occupied' (2.279 million households, 34.3%) and 'rent with deposits' (1.159 million households, 17.5%).

[One-person households by type of living quarters and occupancy (2020)]




[Housing status]

The average residence period per household stood at 8.7 years. The older household head, the longer residence period.

- O In 2020, the average residence period per household stood at 8.7 years, dropping by 0.1 year from 8.8 years in 2015.
- The average residence period of household heads aged 29 or less recorded 2.1 years. The average residence period of household heads aged 70 or more recorded 16.5 years. The older household head, the longer residence period.

As for the occupancy type of living quarters of general households, 'owner-occupied' recorded the largest share at 57.3%. From 2015, the share of monthly rent was higher than that of rent with deposits. Afterwards, this trend continued.

- O As for the occupancy type of general households, in 2020, 'owner-occupied' recorded the highest share at 57.3%, which was followed by 'monthly rent' (22.9%), 'rent with deposits' (15.5%), 'rent-free' (3.7%) and 'lump sum pay' (0.6%).
- From 2015, the share of monthly rent was higher than that of rent with deposits. Afterwards, this trend continued.
- O As for occupancy type by age of household head, 'monthly rent' took up the largest share for household heads aged 29 or less. 'Owner-occupied' took up the largest share for household heads aged 30 or more.

(Vacant houses)

In 2020, the number of vacant houses was 1.511 million units. As for reasons for vacancy, 'sale, lease or moving' occupied the largest share at 42.9%, which was followed by 'occasional use' (27.1%) and 'unsold or not moving in' (13.9%).

- O In 2020, as for vacant houses by type of housing, apartments occupied the largest share at 54.9% (830 thousand units). This figure was followed by detached houses (22.5%, 339 thousand units) and apartment unit in a private house (16.1%, 243 thousand units).
- As for reasons for vacancy, 'sale, lease or moving' occupied the largest share at 42.9%. This figure was followed by 'occasional use' (27.1%) and 'unsold or not moving in' (13.9%).
